Open and Honest Care at Tameside and Glossop Integrated Care NHS Foundation Trust : October 2016

This report is based on information from October 2016. The information is presented in three key categories: safety, experience and improvement. This report will also signpost you towards additional information about Tameside and Glossop Integrated Care NHS Foundation Trust's performance.

1. SAFETY

Safety thermometer

On one day each month we check to see how many of our patients suffered certain types of harm whilst in our care. We call this the NHS Safety Thermometer. The safety thermometer looks at four harms: pressure ulcers, falls, blood clots and urine infections for those patients who have a urinary catheter in place. This helps us to understand where we need to make improvements. The score below shows the percentage of patients who did not experience any harms.

97.7% of patients did not experience any of the four harms

Health care associated infections (HCAIs)

HCAIs are infections acquired as a result of healthcare interventions. Clostridium difficile (C.difficile) and methicillin-resistant staphylococcus aureus (MRSA) bacteremia are the most common. C.difficile is a type of bacterial infection that can affect the digestive system, causing diarrhoea, fever and painful abdominal cramps - and sometimes more serious complications. The bacteria does not normally affect healthy people, but because some antibiotics remove the 'good bacteria' in the gut that protect against C.difficile, people on these antibiotics are at greater risk.

The MRSA bacteria is often carried on the skin and inside the nose and throat. It is a particular problem in hospitals because if it gets into a break in the skin it can cause serious infections and blood poisoning. It is also more difficult to treat than other bacterial infections as it is resistant to a number of widely-used antibiotics.

We have a zero tolerance policy to infections and are working towards eradicating them; part of this process is to set improvement targets. If the number of actual cases is greater than the target then we have not improved enough. The table below shows the number of infections we have had this month, plus the improvement target and results for the year to date.

The rigorous Root Cause Analysis is in place to determine whether a 'lapse in care' occurred for the 12 Cdifficile cases during the month of October and as a result this number may be subject to change.

Pressure ulcers

Pressure ulcers are localised injuries to the skin and/or underlying tissue as a result of pressure. They are sometimes known as bedsores. They can be classified into four categories, with one being the least severe and four being the most severe. **The pressure ulcers reported include all validated avoidable/unavoidable pressure ulcers that were obtained at any time during a hospital admission that were not present on initial assessment.**

This month 18 pressure ulcers were acquired during hospital stays.

The pressure ulcer numbers include all pressure ulcers that occurred from hours after admission to this Trust.

So we can know if we are improving even if the number of patients we are caring for goes up or down, we also calculate an average called 'rate per 1,000 occupied bed days'. This allows us to compare our improvement over time, but cannot be used to compare us with other hospitals, as their staff may report pressure ulcers in different ways, and their patients may be more or less vulnerable to developing pressure ulcers than our patients. For example, other hospitals may have younger or older patient populations, who are more or less mobile, or are undergoing treatment for different illnesses.

Rate per 1000 bed days:

Falls

This measure includes all falls in the hospital that resulted in injury, categorised as moderate, severe or death, regardless of cause. **This includes avoidable and unavoidable falls sustained at any time during the hospital admission.**

This month we reported 1 fall(s) that caused at least 'moderate' harm.

So we can know if we are improving even if the number of patients we are caring for goes up or down, we also calculate an average called 'rate per 1,000 occupied bed days'. This allows us to compare our improvement over time, but cannot be used to compare us with other hospitals, as their staff may report falls in different ways, and their patients may be more or less vulnerable to falling than our patients. For example, other hospitals may have younger or older patient populations, who are more or less mobile, or are undergoing treatment for different illnesses.

2. EXPERIENCE

To measure patient and staff experience we ask a number of questions. The idea is simple: if you like using a certain product or doing business with a particular company you like to share this experience with others.

The answers given are used to give a score which is the percentage of patients who responded that they would recommend our service to their friends and family.

The Friends and Family Test

The Friends and Family Test (FFT) requires all patients, after discharge, to be asked: *How likely are you to recommend our ward to friends and family if they needed similar care or treatment?* We ask this question to patients who have been an in-patient or attended A&E (if applicable) in our Trust.

In-patient FFT score*	97.23	% recommended	This is based on 686 responses.
A&E FFT Score	80.58	% recommended	This is based on 968 responses

We also asked 32 patients the following questions about their care:

If you were concerned or anxious about anything while you were in hospital, did you find a member of staff to talk to?	91
Were you given enough privacy when discussing your condition or treatment?	94
During your stay were you treated with compassion by hospital staff?	91
Did you always have access to the call bell when you needed it?	97
Did you get the care you felt you required when you needed it most?	97
How likely are you to recommend our ward/unit to friends and family if they needed similar care or treatment?	88

We asked 30 staff the following questions:



Guidelines produced by the National Institute for Health & Care Excellence (NICE) make recommendations to ensure safe staffing levels on adult wards in acute hospitals and maternity settings. In-line with this guidance we are required to publish monthly reports showing the number of Registered Nurses/Midwives and Health Care Assistants (Care Staff) working on our in-patient wards.

Each month the data compares the number of staff hours 'Planned' against the number of staff hours used 'Actual'. This is collected by ward, by shift, and is reported by calendar month as a % fill rate by day and by night.

Improvement story: we are listening to our patients and making changes



Virtual Fracture Clinic

The Virtual Fracture Clinic is a consultant-led service and is driven by the Orthopaedic Department, with the support of the Physiotherapy and Emergency Departments. The clinic commenced on 19 September 2016.

What is a Virtual Fracture Clinic?

- If a patient sustains an injury, it will be assessed and treated by the Emergency (A&E) Department
-
- Instead of being booked an appointment in the Fracture Clinic, patient's injuries and x-rays will be reviewed by a Consultant and a Physiotherapist
-
- Patient's will be contacted by phone shortly after the virtual clinic to confirm a plan of management and provide any further information they may need – even if no face to face follow-up is thought to be required
-
- Any information will be confirmed in a letter and sent to the patient

What will it mean for patients?

- Enables self-care and treatment of injuries at home where possible
-
- Reduced visits to the hospital
-
- Reduced delays in Fracture Clinic if patients need to attend an appointment

What is a Virtual Fracture Clinic?

Your Injury has been assessed and treated by the Emergency (A&E) Department

Your injury and x-rays will be reviewed later by an Orthopaedic Consultant (a doctor who specialises in fractures or broken bones).

Many injuries heal well over time without any further treatment. However, an appointment will be arranged for you if deemed necessary. **If you do require an appointment, please allow up to 3 hours when you attend.**

You will be contacted by phone within the next few days to confirm a plan of management and provide further information – even if no follow-up is thought to be required. Any information will be confirmed in a subsequent letter.
